

Tenure-Track Assistant Professor of Criminal Justice (Position # 197390/Job # 498585)

The Department of Criminal Justice at New Mexico State University invites applications for one tenure-track Assistant Professor Position beginning August 19, 2024.

About the Department: The Department of Criminal Justice is in the College of Arts & Sciences and offers a Bachelor of Criminal Justice and a Master of Criminal Justice (on campus and online). We are an interdisciplinary faculty and our Department includes eight tenured/tenure-track faculty and two full-time college-track faculty. Faculty are expected to serve both the online and campus programs. We serve approximately 600 undergraduate majors and 40 graduate students. Faculty research areas include national and international policing, juvenile justice, the death penalty, corrections, courts and sentencing, race, immigration, identity formation, and the borderlands.

Description of Duties: Successful applicants must demonstrate the ability to contribute to the mission of the Department in teaching, research, and service. The specific responsibilities of the position include teaching 9 credit hours per semester of some combination of undergraduate and graduate courses online and on-campus from existing curriculum and new courses created in an applicant's specialty area, student advising/mentoring, conducting scholarship/research, participating in university and community service.

Required Qualifications: Ph.D. in Criminology, Criminal Justice, or closely related discipline by August 18, 2024. ABDs may apply, but degree must be in hand by the start of employment; a J.D. alone is not sufficient for the position. We are looking for someone whose research specialty is in the area of criminology and criminal justice although we will consider candidates able to complement existing areas of specialty of our multi-disciplinary faculty.

Preferred Qualifications: We seek exceptional candidates who can teach a variety of criminal justice required courses, including but not limited to, criminological theory, juvenile justice, or policing at the graduate and undergraduate levels. The ability to teach in other areas that enhance and/or complement current departmental strengths is welcomed. The potential for extramural funding is also desirable.
